



# 2019 S&H Campground Guidelines

## RVs • Tents • Cabins • Trailers

**Registration:** Law requires all campers to register before occupying a camping space.

**Visitors:** Any visitors you have at the park must register and pay applicable fees before entering the camping area. If you prefer, you may pre-pay your visitor's fees, but they must still register with the office. Daily visitors must leave the campground by 10:30pm or they will be responsible for paying the overnight camping rate.

**Speed Limit:** For everyone's safety, please obey the 5 MPH speed limit.

**Children:** Parents are responsible for their children and their safety. Do not leave your children unattended.

**Pets:** This is a pet friendly campground; however, we do require that you use a leash. Pet owners are responsible for properly disposing of their pet's feces. No pets are allowed in the lake, pool, office, activity center, cabins or trailers. Please do not leave your pet unattended on the grounds.

**Mail:** We allow mail to be delivered, and mail pick-up will happen three days a week.

**Alcohol:** Please keep all alcoholic beverages on your site. Alcohol is not permitted around the playgrounds, lake, or pool.

**Pool:** No lifeguard is on duty, swim at your own risk. An adult must accompany children under 14, or they will be asked to leave. Parents are responsible for their children. There shall be no cutoff shorts, pets, food, and drinks, smoking, running, and/or jumping.

**Fishing:** No license required for the lake. License required in creek if you are over 16 years old. Wardens watch closely, and the fines are heavy for violators. Fishing from bridge is prohibited. There is a 3 fish limit. All fishing stops at 10:30pm.

**Security:** Display sticker or camping pass in your windshield. For your safety, all vehicles without a sticker or pass will be stopped.

**Quiet Hours:** Please be considerate of your neighbors and observe the quiet hours of 10:00pm to 8:00am.

**Check Out:** Cabin occupants are to check out with the office by 11:00am. All campers are to be checked out by 11:00am. If you would like to extend your stay with us, please let us know as soon as possible.

**Bathrooms:** Everyone likes a clean bathroom; please help us to keep it that way. An adult should accompany all children under 8. NO washing of clothes or dishes in the bathrooms.

**Clotheslines:** Clotheslines are not permitted.

**Laundry Facilities:** Laundry facilities are located between the bath house on the hill.

**Dumpsters:** Do not leave trash on the ground or put trash on top of dumpsters. Please respect our land and properly dispose of trash in the dumpsters provided.

**Vehicles:** Each campsite is allowed 1 vehicle. Washing or repairing vehicles on your campsite is prohibited.

**Trees:** Do not chop or cut any trees or shrubs, violators will be fined. We have firewood for sale at the office.

***For everyone's protection, the following things are prohibited on the grounds.***

**Gray Water:** State Law prohibits draining of gray water onto the ground or in the lake or creek. Please use a bucket and empty at the dump station.

**Fireworks:** Display or use of fireworks by campers is not permitted.

**Firearms:** Firearms or other weapons are not permitted on the grounds.

**Equipment:** Campground equipment is not to be removed from the grounds. Tampering or adjusting park equipment, utilities, or facilities are not permitted.

**Trees/Wildlife:** Removal of trees, shrubs, seedlings, or plants is not permitted. Hunting is not permitted.

**Digging:** Digging and/or the use of metal detectors are not permitted.

**Soliciting:** Soliciting of any kind is not permitted on the grounds.

You are responsible for any damages that are incurred during your stay at S&H Campground. If damages exceed the deposit amount, your credit card will be charged the remaining amount. You will be notified of such charges.

Please review our cancellation policy.

Cancellation Policy: In the event that a reservation must be cancelled, or the duration of the camper's stay is affected in any way, the camper is given a future credit to use at S&H Campground with no expiration.
